I. Summary

Project Manager, Chad Grisier, P.E. with P.E.C solicited for bids for the repair of Unit #10 at the Cushing Power Production Plant. Two bids were opened on April 14, 2023, one from Cooper Machinery Services and the other from Blackstone Industrial Services. Unfortunately, Blackstone Industrial Services failed to follow the stipulations outlined in the bid documents so their bid was disqualified and cannot be considered. The bids were as follows:

PROVIDER	BID AMOUNT
Cooper Machinery Services	\$ 568,808.95
Blackstone Industrial Services	\$ 263,458.06

The engineer's estimate was \$935,000.00 so the acceptable bid was well under the projection.

Staff is recommending executing an agreement with Cooper Machinery Services for the repair of Unit #10.

II. Fiscal Impact

This was not an anticipated expense, so it was not included in the FY 22 -23 budget. Finance Director Jerrica Worthy has prepared a budget amendment, which is being presented as part of the consent agenda for Trustee approval.

Staff is recommending a 25% contingency be built into the project budget to capture any unexpected repairs that are not currently known. The repair cost (\$568,808.92) and the contingency (\$142,202.00) will bring the project budget total to \$711,011.00. Finance is recommending this amount be rounded up to an even \$715,000.00. (Line-Item No. 252-500-5519 – Engine 10 repairs)

III. Recommended Action

Authorize the City Manager to execute a contract with Cooper Machinery Services in an amount up to \$715,000.00 for the repair of Unit #10 at the Cushing Power Production Plant, and to authorize payment.

I. Summary

On April 11, 2023, the City of Cushing received bids for the construction of the 69kV line from 9th and Little Street to the New Harmony Substation. Only (1) one bid was received, and it was significantly higher than the estimated cost from Allgeier, Martin and Associates. Therefore, we recommend that the City of Cushing reject the bids and go back out and rebid with some adjustments to the bid. We will send a bid packet to a much larger contractor pool with the hope of getting more bids.

II. Fiscal Impact

Funding for this project is included in the FY 22-23 budget (252-500-5555), This action will not have any effect in the budget.

III. Recommended Action

To reject the construction bid contract CU-23-1LM from Re-Con Company, Inc. for the construction of the 69kV line and rebid project.
